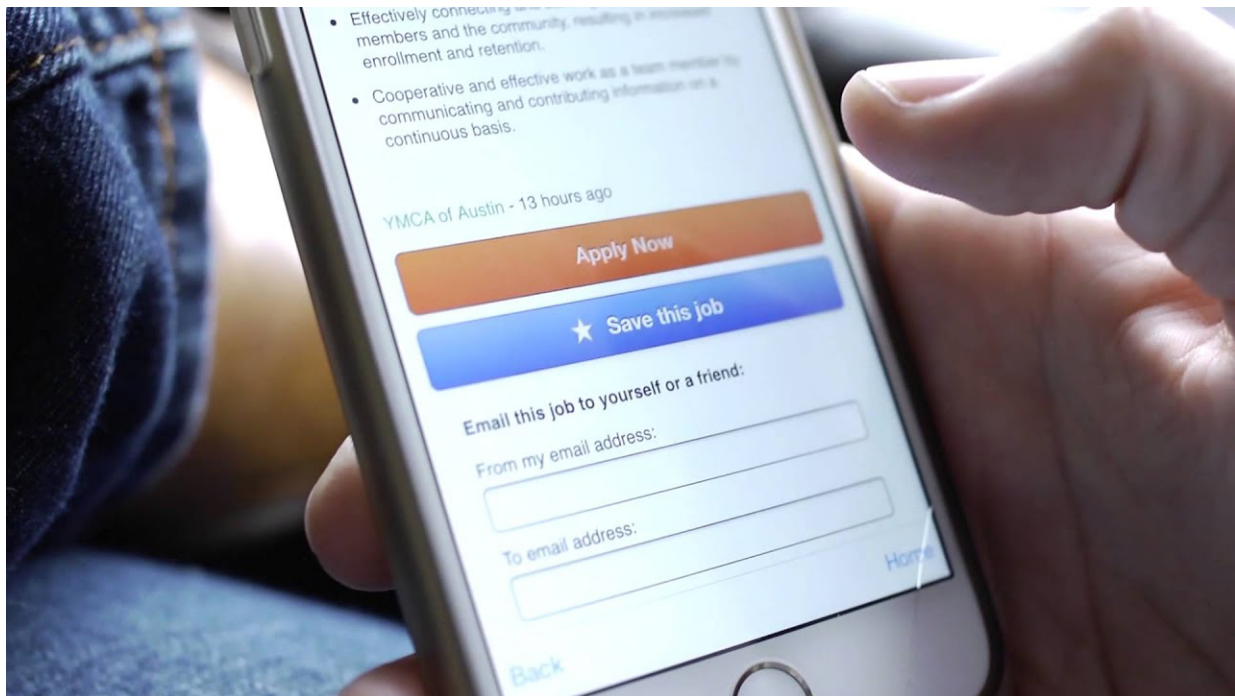

Note About the I-9 Form Expiration

The I-9, Employment Eligibility Verification Form, that employers have been using since July 2017 expired on August 31, 2019. Until USCIS makes any additional announcements on I-9 Central, employers should plan to continue to use the current form. There is still no update on this as of 10/4/2019.
